ORDER

SAFEGUARDING THE INTERESTS OF THE SC/ST CATEGORIES IN MATTER OF EMPLOYMENT WITH THE GGSIP UNIVERSITY AND ADMISSIONS TO THE UNIVERSITY SCHOOLS AND AFFILIATED COLLEGES/INSITUATIONS

1. This is in supersession of the University's order of even number dated 23.05.2013, the Competent Authority, Guru Gobind Singh Indraprastha University, is pleased to constitute a monitoring mechanism in order to safeguard the interests of the SC/ST/OBC/PWD candidates in matters of the reservation for employment with the GGSIP University and for those prospective students seeking admission in various academic programmes of the University, with immediate effect, as follows:

(i) **Liaison Officer for SC/ST**: Prof. Pushpendra Singh Bharti, Professor, USICT, GGSIPU.

The liaison officer will be responsible for monitoring the implementation of reservation policy for SC/ST, issued by the UGC and/or by the State Govt. from time to time.

(ii) **SC/ST Cell**:

The SC/ST Cell will examine the grievances of the members of these communities and will function under the overall supervision of the Liaison Officer. The SC/ST Cell will meet at least once in every semester.

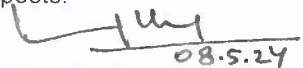
